PREFACE Welcome to the Seventh Edition of Federal Prosecution of Election Offenses, a project that has been in the works for over two years. This book replaces the Sixth Edition, which was published in 1995, and represents a complete re-write of that last book. There have been a number of significant developments in the law dealing with elections and election finance - and, accordingly, in the Departments enforcement approach in this area - since we last wrote on these subjects. In 2002, Congress passed the Bipartisan Campaign Reform Act (BCRA). One of the goals of this legislation was to close major loopholes involving so-called soft money and issue advocacy that had developed since enactment of the original Federal Election Campaign Act (FECA) in 1971. Another of BCRA's goals was to provide enhanced criminal penalties for knowing and willful FECA violations. Yet another goal was to put in place a strong sentencing guideline for FECA crimes. The following year the United States Sentencing Commission obliged, promulgating a sentencing guideline, U. S. S. G. 2C1. 8, that recommends imprisonment for most campaign financing offenses. Subsequent First Amendment challenges to BCRA's broad provisions were resoundingly rejected by the Supreme Court, which upheld the landmark provisions as constitutional anti-corruption measures designed to address public corruption and the appearance of public corruption. *McConnell v. Federal Election Commission*, 540 U. S. 93 (2003).
